#### **Tenant Waterfall**

- The tenant waterfall is a risk mitigation tool for the Projects should rental demand by targeted Accompanied Military Personnel not materialize or diminish.
- The waterfall is located in the Ground Lease and most of the tiers are similar across projects in the portfolio.
- With declining occupancy across the portfolio, more and more projects are using the tenant waterfall to boost occupancy, fund project operations and ensure that debt service is paid.



#### **Tenant Waterfall Structure**

CATEGORY	PRIORITY
Key and essential accompanied or unaccompanied military or civilian personnel assigned or attached for duty at the Installation	1
Accompanied military personnel and unmarried chaplains assigned or attached for duty at the Installation	2
Accompanied military personnel assigned or attached for duty within a 50 mile radius of the Installation	3
Unaccompanied family members of military personnel	4_
Unaccompanied military personnel (married and single) assigned or attached for duty as stated in (2) or (3) above	5
Retired military personnel and spouses or widowed spouses of retired military personnel	6
DoD and Federal Agency civilians (other than designated Key & Essential)	7
Federal Government Contractors with access to Redstone Arsenal and Retired Federal Government Civil Service Employees that retain access to Redstone Arsenal	8

#### **Tenant Waterfall Utilization**

 Use of the Tenant Waterfall spans across all services and many installations. All residents Tier 6 and below are subject to background/credit checks and any additional restrictions as agreed to by the partnership.

# **Tenant Waterfall Utilization (cont.)**

• When the Army decided to retire the 3/1 BCT at Fort Knox, the significant departure of military soldiers and their families would have a negative impact on project operations. The property management team has supplemented occupancy with prospective tenants from the waterfall, opening up housing to the last tier (General Public). As of Q1 2015, the project has averaged 71.3% occupancy, a 13.9% increase from budget expectations.





# **Tenant Waterfall Utilization (cont.)**

Redstone Arsenal is another project that heavily utilizes the tenant waterfall. BRAC 2005 relocated the Army Materiel Command (comprised primarily of Senior Officers) to Redstone (a project with a majority of JNCO/JENL housing). Property management aggressively pursues civilians, retirees and federal contractors to occupy these homes. As of June 2015, 63% of housing is occupied by waterfall tenants.





## **Army Coordination**

- Some Garrison Commanders are not receptive to the idea of having non-military personnel living on-post.
- Communication prior to implementation and explanation of benefits to the project is key.
- Need to develop a vetting process for Civilians.
